- 7.2 **Make-up:** Contestants are allowed to wear make-up and do hair styling according to the appropriateness only with the cosmetics provided by the Contest. Nevertheless, the Contest also provides all the contestants the professional make-up artists to assist in make-up process without any charge. Accessorizing with any hair wigs, hairpiece, etc. is considered infringing upon the Rules and Regulations. information are solely eligible to the Contest to allocate, organize and permit such performances for the contestants. 
